



# SUPERINTENDENT OF LEARNING

The Peterborough Victoria Northumberland and Clarington Catholic District School Board (PVNCCDSB) invites applications for the position of Superintendent of Learning. The position will commence at a date to be mutually negotiated following appointment.

The jurisdiction of the board includes the Counties of Peterborough and Northumberland, The City of Peterborough, the City of Kawartha Lakes, and the Municipality of Clarington. The PVNCCDSB serves more than 14,000 students in 36 schools and employs over 2,000 teaching and support staff, with an annual operating budget in excess of \$175 million. The Board's Head Office is located in Peterborough, Ontario, which is situated approximately 1.5 hours from Toronto. This diverse area boasts extensive cultural and recreational opportunities which contribute to the tremendous pride and success that this system continues to experience.

Reporting to the Director of Education, the successful candidate will be an integral part of the senior leadership team and share responsibility for supporting the board's vision: Achieving Excellence in Catholic Education - Learn, Lead, Serve. The Superintendent of Learning will possess the necessary knowledge, skills and attributes to support PCNCCDSB's Vision and Strategic Priorities. The candidate will have the proven ability to create meaningful, systemic and sustainable change in the implementation and monitoring of effective instructional and assessment practices for ALL students, and in leveraging technology for learning.

The candidate will model and support positive relationships and learning partnerships between school, home, parish and the larger community. The candidate will demonstrate exemplary leadership practices and have the necessary cognitive, social and psychological resources expressed in the Catholic Leadership Frameworks.

Candidates for the role must be in good standing with the Ontario College of Teachers, and hold Ontario Supervisory Officers' Qualifications (or are enrolled in the program). Additional qualifications in Religious Education, a proven record of successful teaching, and several years of successful leadership experience are required. Additional qualifications in Special Education are preferred.
