All newly appointed administrators must submit their OPC membership application forms within 60 calendar days of their appointment or risk loss of historical legal coverage for any employment-related event or circumstance that arose or occurred prior to becoming a Member.

Members in boards\* participating in our OPC Benefits plan must also submit their Group Benefits application forms for Long Term Disability Insurance (LTDI) within 60 calendar days. Enrolment will be completed upon receipt of the application forms and premium will be retroactive to the date of appointment.

Medical evidence of insurability and Insurer's approval will be required if the application forms are received after 60 days. Members who did not have LTDI coverage up to their date of appointment must submit medical evidence.
