#### **Your Duty to Report**

One of the many duties of OPC Members is to report abuse and/or neglect of children and youth. As a professional educator working and supporting others who work directly with students, **you have a legal and ethical duty** to report to a Children's Aid Society (CAS) when you have reasonable grounds to suspect that a child is or may be in need of protection.

Our Protective Services Team (PST) receives calls from Members who are, from time to time, uncertain about the circumstances under which to make such reports. The 2018 <u>Professional</u> <u>Advisory</u> of The Ontario College of Teachers states, "When in doubt about whether to make a report, call your local children's aid society." <u>Our advisory on this issue</u>reminds you that **calls to a CAS or other child protection agency of a consultative nature should not be made**: a report is a report. The act of making a report under the CYFSA is, by nature, stressful. Members may seek support and guidance from their Superintendent, through their employee assistance programs or by calling our PST.
