Managing Escalated Interactions With Parents

Among your many statutory and operational responsibilities, principals and vice-principals are accountable to, and face potential relationship challenges with, numerous stakeholders, including the parents/guardians of students. When an administrator encounters an upset parent, it is important to deal with the situation in a progressive manner, focusing on facts, issues and solutions rather than personal conflict and emotions. If you know that a parent has the potential to be challenging, and/or you are about to prepare for a possible difficult interaction, seek support from applicable board staff and contact our Protective Services Team as soon as possible. Update: John Fisher Junior Public School (Toronto)

Further to the <u>public statement</u> that we released on March 8, 2023, we wanted to share that the Toronto Police Services (TPS) has concluded its investigation into the allegations at John Fisher Junior Public School. The TPS found no evidence to support the laying of any charges and concluded that there was nothing to indicate that the staff's actions were based on race. The TPS has now closed its investigation and no criminal charges will be laid.
